

# Portions of 35 Streets May be Resurfaced in 2009

The Village of Palatine has compiled a list of 35 streets targeted for resurfacing in 2009. If bids for the work come in higher than expected, some of the streets may have to be eliminated from this year's program. A total of \$2.28 million has been budgeted for street resurfacing this year.

Using both on-site visual inspections and computer projections, the Department of Public Works has recommended that sections of the 35 streets, listed at the right, should be resurfaced to keep them from deteriorating further and to extend their life an additional 12 to 15 years. Some of these streets have had extensive watermain and sewer repairs done in the last year, and because of this work, need resurfacing.

The average time from start to finish on any one street, not including pavement markings and landscaping, is 40 days. Improvements planned include the spot replacement of curb and gutter, adjustment of manholes and inlets, and asphalt overlay.

Work is expected to start in mid-March with an anticipated completion date of mid-July.





## Was Your Parkway or Mailbox Damaged During the Snowplowing Season?

If so, please call the Village's Public Works Department at (847) 705-5200 to report it. Public Works crews inspect every parkway in the Village to check for damage at the end of the snowplowing season. However, homeowners whose parkways or mailboxes have sustained damage are invited to call and make sure they are on the list.

Crews will repair damaged parkway areas with black dirt and seed. Please note that damage caused by salt is not included in the parkway repair program. In nearly all cases, grass damaged by salt will regrow, although sometimes more slowly than the homeowner would like.

Mailbox and post damage is usually caused by the force of wet, heavy snow being pushed against the post by the plow, rather than the post being struck by the plow itself. If you believe your curbside mailbox was damaged during snowplowing operations, call the Department of Public Works at (847) 705-5200. The Village will replace damaged posts and/or mailboxes that meet Village Code. The Village's total liability is limited to the cost of replacing a standard metal mailbox and/or standard pre-treated wood post.

## ■ Grace Period Registration and Voting

and Suburban Court Houses

**When:** March 11, 2009 through March 24, 2009

There is only one way to register to vote during the 14-day grace period. Unregistered voters must sign up to vote, in person, at the Cook County Clerk's downtown Chicago office: 69 W. Washington St., Room 500 or any of the suburban courthouses. You must show two pieces of identification to register.

Grace-period registrants are not allowed to vote at the polls on Election Day or vote at any early voting site.

## ■ Early Voting (no excuse or reason needed)

Registered voters in suburban Cook County can vote early from Monday, March 16, 2009 through Thursday, April 2, 2009, at any one of the early voting sites which are scattered across suburban Cook County, as well as downtown Chicago. The Village of Palatine, 200 E. Wood Street, is one of the Early Voting sites. The hours are Monday through Friday, 9:00 a.m. to 5:00 p.m., and on Saturday (March 21st & 28th) from 9:00 a.m. to 12:00 noon. Early voting will be conducted on touch screens that store every ballot style in the county, permitting any voter in suburban Cook to vote at any location. Early Voters must show a current government-issued photo ID (Illinois Driver's license, a State ID, or a Passport) to vote early. 


pockets of our stakeholders.

The 2009 Annual Budget and Capital Investment Plan reflects the uncertain economic climate that we all live and work within. It was developed with a theme of "Restrained Optimism," with the commitment to fund essential services to our residents and proceed with extreme caution on other programs and projects.

Revenues were projected on a very conservative basis given the current economic times. Property taxes were only increased by a modest 2.85% and the general fee schedule was scaled back from the statutory Municipal Cost Index increase of 8.1% to 3.5%. Sales tax projections included provision for new businesses as a result of the Village's economic development activities and for the unfortunate loss of businesses due to relocation and the economy.



Departmental operating budgets were created with a "maintenance of effort" approach. This was to assure that the quality services our stakeholders have come to expect would not be compromised. This is critical when considering the composition of our expenditures by function as shown below.



The adopted budget includes a list of items that are on a "hold list". These items, totaling approximately \$3.0 million, are on "hold" until a mid-year review of our financial situation. Should our revenue projections hold, they will be undertaken; however, if the economy continues to decline and revenues not come in as projected, they will not.

The following are key public health, safety, and welfare initiatives included in the operating budget for fiscal 2009:

- Addition of Part Time Police Assistant – The most economical solution to cover periods of heavy call volume to meet the demand for services.
- Operation IMPACT – Operation IMPACT (Immediate ManPower Against Criminal Threat) is an overtime program that targets designated areas of the Village to combat criminal threats and trends. Officers work in non-traditional patrol styles – in pairs, on foot, on bicycle.
- Additional K-9 Unit – The Village's K-9 unit continues to be an essential part of our police work. The demands for the unit expand every year. The Annual Budget includes funding for a second K-9 unit.
- Squad Car Cameras – Equip 50% of the marked fleet with cameras. This will assist in the successful prosecution of violators, deter false accusations and determine liability when accusations are made as well as provide for training opportunities for our officers.

Our Capital Investment Plan continues to focus on our infrastructure from street resurfacing and reconstruction to new water and sewer services. There are improvements to our creek system to help control storm water and upgrades to our technology systems to deliver the most efficient services possible.

Palatine consistently ranks as one of the most efficient municipal governments when it comes to cost of government per capita. Based upon a survey of comparable communities:

Palatine ranks #1 in Fewest Employees Per 1,000 Population  
Palatine = 5.83 Employees Per 1,000  
Average = 7.41 Employees Per 1,000

Palatine ranks #2 in Lowest Operating Expenditures Per Capita  
Palatine = \$967.71 per capita  
Average = \$1,290.87 per capita

The 2009 Annual Budget and Capital Investment Plan will serve as a strategic guide for the Village in the coming year. It reflects the services expected by our residents, provides dedicated revenues to support our long term infrastructure and equipment needs and lives within our financial means. The budget prioritizes our core services and administrative functions. Our employees continue to be the key to operational and financial success. Palatine remains committed to providing the highest quality services at one of the lowest costs.

# Isolated Problems Remain, But Significant Progress Made in Neighborhoods Prone to Flooding

Following two exceptionally heavy rainfalls in the fall of 2001, the Village Council adopted an aggressive program to reduce the frequency and severity of flooding in areas where property damage was occurring. Four areas of the Village – Palanois Park, Buffalo Creek, Winston Park and the South Central neighborhoods -- were identified as needing improvements to prevent flooding following heavy rainfalls.

Studies by four independent consultants identified \$20 million in needed flood improvements. Ten million was bonded to cover the cost of the critical improvements under Phase 1 of a two phase program. By the fall of 2004, most of the Phase 1 flood mitigation improvements had been completed in the Palanois Park, Buffalo Creek, Winston Park and the South Central neighborhoods. The remaining Phase 2 improvements were integrated into the Village's annual Capital Improvement Program to be implemented over a series of years.

Following severe rain events in 2007, the Village Council authorized the funds to expedite the Phase 2 flood control improvements. By developing alternate solutions and incorporating improvements that were completed between 2004 and 2007, the total amount of the Phase 2 flood control efforts are estimated at 50% of the cost originally contemplated in 2001.

During the course of 2008 and 2009, over \$4 million in flood control improvements are targeted.

Work completed during 2008 includes:

- Pleasant Hill Boulevard between Salt Creek and Plum Grove Road: Relief Storm Sewer.
- Helen Road between Plum Grove Road and Benton Street: New Storm Sewer.
- Helen Road at Elm Street: New Storm Sewer and Draintile Replacement



- Doe Road: New Storm Sewer and Roadway Adjustment
- North Street at Park Avenue: Draintile Replacement with Storm Sewer
- Williams at Jane Addams: Intersection Reconstruction and Ditch Improvement

Work targeted for 2009 includes:

- Garden Avenue at Del Mar: Relief Storm Sewer and Regrading
- King George at King Edward: Relief Storm Sewer
- Buffalo Creek East of Capri Drive: Rehabilitation of Channel Profile and Bank Stabilization
- Williams Drive at Paddock Drive: Relief Storm Sewer
- Williams Drive at Clark Drive: Relief Storm Sewer
- Hale Street between Gilbert and Glade: Storm Water Lift Station
- Fairgrounds Park: New Storm Sewer

Areas affected by flood control improvement work will be notified before work begins.

## Here's a Bright Idea: Recycle Your Compact Fluorescent Bulbs at the Village

The Village of Palatine's Environmental Health Division is now offering residents a new drop off program for recycling Compact Fluorescent Lightbulbs (CFL) and fluorescent light bulbs up to 4 feet in length. This free program is being sponsored by the Solid Waste Agency of Northern Cook County (SWANCC). Those bringing fluorescent bulbs to the Village for recycling will be asked to show identification for proof of residency. Please note that this program is for residentially-generated CFLs only. No commercial or institutional waste will be accepted.

### Collection Dates, Locations and Times

Residents should bring CFLs for recycling in sealed plastic bags. This program offers residents an environmentally responsible recycling option for CFLs as an alternative to putting them in the garbage. Each CFL contains a very small amount of mercury sealed within the glass tubing, and therefore should not be disposed of in the garbage.



### Cleanup Guidelines for Broken CFLs

Research indicates that there is no immediate health risk to you or your family from the small amount of mercury in CFLs, should a bulb break. You can minimize any risks by following these proper clean-up and disposal guidelines:

1. Open the window to ventilate the room if the weather permits.
2. Use rubber gloves if available and wash hands when finished. Wipe the area clean with damp paper towels or wet wipes and place in plastic bag and seal.
3. Do not use a vacuum or broom for clean up. On hard surfaces, scoop up glass fragments and fine particles with cardboard. On carpeting, use tape to collect glass fragments and fine particles. Place in a plastic bag for disposal.
4. Double bag and seal all clean up materials and then dispose of in the garbage.

# If Basement Flooding is a Problem, We Can Help with the Solution



The record rainfall of August 23, 2007 is a nearly forgotten event for some, but a vivid memory for those whose basements took on inches of water and/or raw sewage that day.

In response to that flood event and the number of Palatine homes affected, the Village Council expanded the Sanitary Sewer Low Interest Loan Program to also provide Village funding to encourage homeowners to upgrade their gravity sanitary sewer services to either overhead plumbing or the installation of a back-water valve. Both methods can reduce the likelihood of sewer backups, although the overhead plumbing provides the higher level of protection.

With this expansion of the Sanitary Sewer Low Interest Loan Program, the Village is offering loans and/or cost-sharing to assist residents in making improvements to protect their basements from back-ups. The types of improvements covered under the program include:

- Sewer backwater valves.** The Village will contribute 50% of the cost to a maximum of \$750.
- Conversion to overhead plumbing.** The Village will contribute 50% of the cost up to a maximum of \$5,000, including required disconnection of footing drains.
- Disconnection of gravity footing drains from the sewer service.** The Village will contribute 50% of the cost up to a maximum of \$2,500. If you don't have a footing drain sump pump, this should be done as you still may have basement flooding with a check valve as the footing drain water will have no where to go when the check-valve closes. Disconnection of the footing drains also eliminates the major source of

excess storm water that overloads the Village's sanitary sewer system which causes the basement back-ups in the first place. Disconnection of footing drains is necessary to receive the Village contribution for installation of a backwater valve or overhead plumbing.

- Replacement of the sewer service laterals from the house to the sanitary sewer main.**
- Replacement or repairs of foundation footing drains.**
- Replacement or installation of basement window well drains.**


All of these improvements are eligible for a grant and a low interest loan that can easily be applied for through the Village. The loan amount ranges from \$1,000 to \$10,000 and have a term of 10

years. The interest rate is determined yearly based upon the State Treasurer's rate. To further reduce the costs associated with these projects, the Village will waive all applicable building permit and review fees. Inspection fees apply.

## The Good News Is – It Works

As a testament to the success of converting to overhead plumbing or installing backwater valves, a survey of those homeowners who installed these improvements after the August 23, 2007 extreme rain event and prior to either the September 13 or December 27, 2008 events reported they did not experience sanitary sewer back-up.

# Know the Score: Village's New Food Inspection Postings List Results of Last Three Inspections


While dining out at your favorite restaurant or shopping at the grocery store in Palatine, you may have noticed a change in the design of the food inspection scores posted by the Environmental Health Division.

Food establishments will now display the results of their last three routine inspections at the business entrance. Previous postings displayed the average of the year's inspections rather than the actual inspection score. A perfect food establishment inspection score is 100 points.

This change went in effect as of January 1, 2009 based on the recommendations of the Board of Health and approval by the Village Council. Please note that you may find food establishments with the previous posting design displayed until the new inspection for 2009 is conducted.

The Environmental Health Division staff conducts unannounced routine inspections of over 250 food establishments within the Village of Palatine. Inspections are conducted to verify that the establishments are operating in compliance with the requirements of the Illinois Food Service Sanitation Code. # Reuse-A-Shoe Gives Old Athletic Shoes

## New Life as Running Tracks, Athletic Courts and More



The Environmental Health Division is participating in Nike's Reuse-A-Shoe program sponsored by the Solid Waste Agency of

Northern Cook County. Collected worn out athletic shoes will be transported to the Nike facility and recycled into "Nike Grind" material that goes into making running tracks and other athletic court surfaces.

The Reuse-A-Shoe collection box is located in the main floor lobby of the Village Hall. Drop off your athletic shoes Monday through Friday from 8:00 a.m. to 5:00 p.m. Athletic shoe collection will take place until May 8, 2009.

### Acceptable Shoes:

- Athletic shoes only (any brand)

### Unacceptable Shoes:

- Shoes with metal eyelets, zippers, batteries, cleats or spikes.

## HOW WOULD A NEW TREE LOOK IN YOUR PARKWAY?

Planting trees has multiple benefits for us all. They add beauty, charm, and stately maturity to a community, not to mention cleaner air and a better environment. That's why the Village of Palatine offers a 50/50 tree planting program to encourage residents to plant parkway trees in front of their homes. Through the 50/50 program, the Village and homeowner share the cost of the tree, which includes planting and a one year guarantee. The homeowner's share ranges from about \$110.00 to \$250.00, depending on the size and species of tree selected. Call the Department of Public

Works, (847) 705-5200, for an application for the spring 50/50 parkway tree program. The deadline for applying is **April 17**.

Please note: If the Village has removed a parkway tree within the last year, it will be replaced at no charge to the homeowner. Trees that were removed will be replaced with approved varieties according to availability.



## THE PRICE IS RIGHT: FREE LANDSCAPING MULCH AVAILABLE

Yes, FREE! We'll even deliver it to you for the nominal fee of \$10.00 per cubic yard, with a three cubic yard minimum. The mulch will be dumped on the apron of your driveway. Call the Public Works Department, (847) 705-5200 after March 1 to schedule a delivery. Deliveries will begin in April.

Or if you prefer, you may pick up mulch from the bins in front of the fenced area at the Smith Street Recycling Center from dawn to dusk, seven days a week. Bring a shovel and containers and help yourself.

While it is not considered landscape quality, the mulch is double ground and perfect for the area at the base of trees, around flower beds, and other places in your landscape design.

## READY TO RIDE

The Village of Palatine is well on its way to becoming a more bicycle-friendly community with the recent creation of a Bicycle Task Force. The task force was initiated by residents who are interested in expanding safe bicycling options in Palatine.

If the sidewalk in front of your home is uneven, severely cracked, or deteriorated in a way that meets specific safety standards, you can have it replaced for half the actual cost through the Village's 50/50 Sidewalk Replacement Program. The cost to the homeowner is approximately \$58.00 per sidewalk square. Requests for participation in the 50/50 Sidewalk Replacement Program can be made by calling the Department of Public Works at (847) 705-5200 between 8:00 AM and 4:00 PM Monday through Friday.

The Village's Hazardous Sidewalk Program is designed to identify and eliminate the worst tripping hazards, at no cost to the homeowner. The area targeted for this year is west of Hicks Road, east of Quentin Road, south of Northwest Highway, and north of Illinois Avenue.
