## VILLAGE REDUCES 2011 BUDGET 20 PERCENT; KEEPS CORE SERVICES

Although Wall Street continues to make optimistic headlines based on substantial increases in the stock market, Main Street—located in every municipality—faces declines due to the poor job and housing markets. The Village of Palatine's 2011 budget reflects a "Main Street" outlook for the upcoming year.

The 2011 budget represents a decrease of 20 percent over 2010. In order to maintain fiscal stability, the Village is committed to reducing costs wherever possible and to live within its means without impacting core police, fire and public works services.

In 2010, the Village projected a shortfall of \$3.6 million for the general fund.

Working with the Village Council, the Budget Team was able to reduce the working budget by \$1.37 million through personnel reductions, benefit and contractual obligations, supplies and training programs.

**The 2011 Budget reflects a 'Main Street' outlook for the upcoming year.**

"The economy is getting better, but the uncertainty we still face—coupled with rising costs—forced us to reprioritize all Village services to ensure that our community core programs addressing the public health, safety and welfare remain funded and delivered in an exemplary manner," said Reid Ottesen, Palatine Village Manager.

While 71 percent of the operating revenues come from property taxes, sales taxes and state income taxes,

## VEHICLE STICKERS ON SALE MAY 2

Passenger vehicle stickers for Palatine residents go on sale Monday, May 2 and must be displayed before July 1, 2011.

The cost for each passenger car sticker is \$30 until June 30. Stickers purchased July 1 and later will incur a late payment penalty of \$20 for a total fee of \$50 per vehicle.

Special status stickers are available for \$6 for senior citizens, holders of handicapped license plates, disabled veterans and active military personnel, but are limited to one per household.

Animal tags also must be purchased for \$7 per animal with proof of current rabies vaccination number and must be purchased by July 1.

Vehicle stickers may be purchased by mailing in an application with payment or at the Palatine Village Hall, 200 E. Wood St., Monday through Friday from 8 a.m. to 5 p.m. and Saturdays (only in June) from 8:30 a.m. until 12 noon.

For your convenience, a night drop box is available on the second floor of Village Hall and a drive-up drop box is located adjacent to the Village Hall building near the Park District tennis courts.

Reminder: Wood Street in front of the Village Hall will be closed to vehicles from June 29 to July 5 due to the Palatine Jaycees Hometown Fest.

Palatine also has initiated an electricity utility tax for a new revenue source with an estimate of \$900,000 for the general fund.


The Village recognizes the important role the business community plays in maintaining a diverse property tax base. The sales tax generated by local businesses provides much needed relief to the property tax burden faced by all property owners.

The Village anticipates an increase of almost four percent in the property tax levy, but 100 percent of this revenue will go to public safety pensions. Sales tax for 2011 will decrease 13.5 percent over the 2010 budget. This is why it is so important to shop local and keep sales tax revenues in our community. Because of the economic downturn we still face serious financial problems. Illinois has had a decrease in income tax revenue which translates into a \$1.5 million shortfall of state funds

for the Village. The Village Council and the Budget Team will continue to maintain sound fiscal policies, smart austerity and creative management to provide good government for the people of Palatine.

## ILLINOIS DRIVER'S LICENSE SERVICES AT PALATINE VILLAGE HALL MAY 18

Secretary of State Jesse White's Driver Services Mobile Unit will be at the Village Hall in Council Chambers, 200 E. Wood St., on Wednesday, May 18 from 10 a.m. to 2 p.m.

Palatine residents who would like to renew, correct or obtain a duplicate Illinois driver's license, apply for an Illinois identification card, or correct a current driver's license are encouraged to attend this convenient event. Vehicle license plate stickers also will be available that day.

An applicant renewing a current Illinois driver's license or identification card need only present a current valid driver's license or identification card. If an applicant is applying for either a duplicate or corrected driver's license or identification card, the applicant must present two forms of acceptable identification.

Persons 75 years and older must visit an Illinois Secretary of State facility to renew their license. Everyone 65 years and older is eligible for a free identification card with proper documentation.

## New Crosswalk Law Protects Pedestrians

According to the Illinois Department of Transportation, cars hit more than 6,000 pedestrians each year, killing 170 people and seriously injuring more than 1,000.

In an effort to protect pedestrians from automobile accidents, Illinois lawmakers initiated a law, effective July 1, 2010, to make motorists more responsible at a pedestrian-occupied crosswalk. Unfortunately, many motorists are still unaware of the law or its consequences.

**Drivers now must come to a complete stop for pedestrians in all crosswalks**—even crosswalks that are unmarked or don't have a stop sign or a traffic signal. The new law also applies to instances when a pedestrian enters the crosswalk against a "Don't Walk" signal or a red light, as the old law required drivers to yield in such cases.

The former crosswalk law required drivers to yield to pedestrians and stop ONLY when necessary. Failing to stop completely now will cost a motorist a citation and a fine ranging from \$50 to \$500.

Pedestrians also should be aware that the safest place to cross the road is in a marked crosswalk, especially with the implementation of this new law. Crossing the road at any place other than a crosswalk is illegal and may bring fines for the pedestrian of up to \$500.



# ENHANCE WATER QUALITY WITH HOLISTIC LANDSCAPING

A yard provides a very personal place to observe the four seasons. The first bulbs of spring, summer vegetables in the garden, fiery autumn colors and winter snowfalls are important annual events. Each season also has its own landscape maintenance needs.

Sound landscape management impacts far beyond individual property lines because of the way landscapes are linked together by water moving through the environment. By recognizing how each landscape is connected to the environment as a whole and managing the landscape with this holistic approach, residents can contribute to the protection and restoration of natural resources, especially water quality.

Where to start? Small seasonal changes in daily landscape management can add up to very big changes in water quality protection.

## Spring

- Recycle winter debris. Rake out leaves, twigs and branches deposited on lawns and gardens during winter storms. Use this material for a new compost pile base or chop it up with a lawn mower or shredder and re-mulch around foundations, under shrubs and trees, and in groundcover beds rather than purchasing bags of mulch. Don't dump brush and leaves into streams or wetland areas. They add excess nutrients to the system and may cause flooding by blocking water flow.
- Sweep up leftover sand from the road or driveway to keep it out of storm drains and local water courses. This sand may contain salt and other pollutants, so don't use it in vegetable gardens, sand boxes, or a

pile "out back." Sift it and store it in buckets for use next winter.

- Avoid "weed and feed" type products that mix pesticides and fertilizers. Why pay for unneeded chemicals that force you to start mowing earlier and more often? Fertilize in mid-May or apply a thin layer of compost to add organic material to the soil. It provides a more balanced dose of nutrients for healthy lawn growth.
- Cover bare soil. If lawn areas are bare or plantings have died over the winter, re-seed or mulch to prevent soil erosion. Consider dead plants as an opportunity to add native species with multiple season interest to the landscape.
- Start a landscaping log to write down what plants are growing well or having problems, what plants were eaten, and what yard chores take too much time. This log will help with next year's plans.

## Summer

- Avoid wasting water. Invest in a rain gauge to keep track of weekly rainfall. Most plants and the lawn are happy with one inch of water per week. Keep the hose coiled up when rain has been plentiful.
- Prevent water evaporation with a two-inch layer or more of mulch in gardens, around shrubs and under trees. It keeps the ground cooler, plants happier and also inhibits weed seed germination. Don't over mulch heat-loving vegetables until the soil temperature is too high or they won't thrive. Organic mulches provide some nutrients as they decompose and reduce the need for fertilizers.



- Avoid lawn stress. Keep the lawn mower blade sharp, mow often enough that no more than one-third of the grass blade is cut off at a time. Mow when the grass is completely dry. A mulching mower blade recycles grass clippings while mowing, returns moisture and nutrients to the soil, and reduces the need for fertilizer.
- Cut down on chemicals or eliminate fertilizers. Upgrade the soil by adding composted organic matter. Chemicals may damage the natural microbial communities in the soil and promote pest problems. Use "Integrated Pest Management" or IPM strategies to reduce toxic pesticide use.

Protecting water quality and the environment just requires a little thought and a little care and provides big benefits for everyone.

May markets will feature beautiful potted flowers, bedding plants of herbs, vegetables and flowers—just in time to get your gardens going and growing! Watch for the Palatine Garden Club's Special Event in May when members bring local perennials from their gardens to sell.

Several University of Illinois Master Gardeners will offer their expertise by answering questions regarding lawn, garden, tree and insect problems.

Be sure to look for environmental "green" soaps, lotions and cleaning products that will be available along with whimsical pottery and hand-painted greeting cards.

Local musicians will entertain shoppers from 10 a.m. to 1 p.m. The market, located in the train station parking lot at Wood and Smith streets, will be open from 7 a.m. to 1 p.m. every Saturday until October 30.

## VILLAGE OFFERS FREE MULCH FOR HOMEOWNER LANDSCAPING

Palatine residents have come to enjoy the double ground wood chips the Village has provided for the past several years. This "green" initiative allows the Village to recycle wood from trees removed throughout the year. Although most of the mulch is used for Village landscaping beds, there also is enough mulch for residents.

A layer of mulch can enhance and protect plants, shrubs and trees by reducing root damage caused by temperature extremes. Mulch can also inhibit weeds, control soil erosion, prevent soil compaction and help prevent soil splashing on to buildings.

Because this is such a popular program, residents are encouraged to call in March to schedule a delivery appointment for April with the Public Works Department by calling 705-5200. The cost is just \$12 per cubic yard. There is a three cubic yard minimum and residents are limited to ten cubic yards per household.

For smaller amounts of mulch, residents may visit mulch bins at the holding center located at 550 N. Smith Street. Please provide your own shovel and containers.



## Change the Clock, Change the Batteries

Daylight Savings Time ends Sunday, March 13 at 2 a.m. It is a good reminder to replace the batteries in all smoke detectors and carbon monoxide detectors to ensure the alarm will sound in an emergency.

The Palatine Fire Department highly recommends that batteries be replaced twice a year. "Spring ahead" an hour in time and plan ahead for safety.



## Jogging Safety Tips

Runners or joggers should never assume that they are in a "safe" neighborhood. Anyone may be a potential victim, which is why attackers often seek out areas where people do feel safe and secure. When you feel safe you instinctively let down your guard while walking or jogging. Take precautions to avoid becoming a victim and always act as a Neighborhood Watch in motion! If you notice someone or something suspicious, trust your instincts. Dial 911 and alert the police. Follow these basic tips while staying fit!

- Jog with a friend.
- Stay alert to the surroundings, occasionally check behind you.
- Stay on busier streets.
- Do not use headphones—or just use one earphone with the volume on low.
- Be cautious of anyone who stops you to ask for directions, money, cigarettes, etc.
- Do not wear any jewelry.
- Carry a cell phone with an "In Case of an Emergency" contact.
- Change your route—patterns become noticeable.
- ALWAYS let someone know your route and your expected time back.
- Avoid night jogging if possible, or wear highly reflective clothing and shoes.
- Wear or carry a whistle.
- Avoid long hedge rows and empty parks.
- Consider a self-defense class.
- Items that you carry may be used against you.
- Dogs are great companions, but don't exhaust a pet.
- Wear sunscreen.

## DISPLAY HOUSE NUMBERS CORRECTLY FOR EMERGENCY FIRST RESPONDERS

In an emergency, whether you need Police, Fire, or EMT personnel, minutes really do count for first responders. Oftentimes these critical minutes can be wasted when responding emergency personnel try to locate poorly marked or unmarked addresses.

Please provide public safety officers the time they need to perform their duty by properly displaying house or business address numbers in accordance with Palatine code. The Village Council, in cooperation with the Fire Prevention Department, designed the code with resident safety in mind. It is simple and inexpensive to comply.



All residences that are set back 50 feet or more from the street must display house numbers six inches high in contrasting colors above the front door. If a house is within 50 feet, numbers may be four inches high. All numbers must be standard lettering (no cursive or Roman numerals).

Corner residences must display house numbers on the front of the building and over the garage.

Although the U.S. Postal Service requires residents who have curbside mailboxes to post house numbers on the mailbox, the code still requires numbers on the house.

Businesses are also required to follow the same guidelines as residents for the height and contrasting colors for street numbers. In addition, businesses must post street numbers on the back door of the business location.

"A good rule of thumb is to wait until it's dark out," said Palatine Fire Marshal Jim Eriksen. "If you can't see the house numbers, neither can we."



## Block Party Guidelines


The Village encourages neighbors to enjoy the summer at organized block parties. The first step is to apply for a block party permit at least two weeks prior to the event. The permit allows neighbors to close off a designated street until 11 p.m.

Block parties are the perfect opportunity for residents to take time to relax with their family and neighbors. It's a good way to meet new families on the block and learn what's going on within the neighborhood.

These events also encourage safety for homes and children as neighbors begin to look out for one another. It's helpful if neighbors (adults and kids) can spot a stranger on their street and know who to alert in the case of an emergency.

Police and Fire department personnel are usually available to attend the festivities to teach youngsters good safety habits.

## Palatine Underwrites 2 Sidewalk Programs

### 50/50 Sidewalk Program

The Village of Palatine annually partners with homeowners for infrastructure repairs with its 50/50 Sidewalk Program. If sidewalks are uneven, severely cracked or deteriorated and meet specific safety standards, residents may qualify for the 50/50 Sidewalk Program.

The homeowner's cost is approximately \$58 for a typical sidewalk square. Applications will be accepted on a first come, first serve basis.

To participate in the 50/50 Sidewalk Program, call the Public Works Department, 705-5200, between 8 a.m. and 4 p.m., Monday through Friday.

### Hazardous Sidewalk Program

The Village's annual Hazardous Sidewalk Program is specifically designed to identify and eliminate the worst tripping hazards at no cost to the homeowner. The targeted geographic area this year is south of Baldwin and Palatine roads, north of Northwest Highway, east of Hicks Road, and west of Wilke Road.

## TREE-LINED STREETS REQUIRE PARTNERSHIP WITH VILLAGE

Palatine is proud to be recognized as a Tree City USA sponsored by the Arbor Day Foundation in cooperation with the U.S. Department of Agriculture Forest Service. To achieve this worthwhile status, the Village and residents participate in the 50/50 Tree Planting Program which allows the Village to plant deciduous trees in parkways by equally sharing the cost with residents.

The Public Works Department plants all parkway trees, which come with a one-year guarantee and one replacement, if necessary. Plantings are available in the spring and fall. In addition to standard sized trees, several varieties also are available for planting under power lines to avoid severe pruning at maturity.

The Village Forester will approve and review all planting locations. Trees will be ordered on a first-come, first-served basis. Priority on tree choice

will be determined by time and date of receipt of order and payment.

Parkway trees removed by the Village will be replaced at no charge to the resident. However, if a resident wants a particular species of tree, he or she will be required to pay half the cost as in the 50/50 Program.

# VILLAGE TARGETS STREETS FOR 2011 RESURFACING PROGRAM

Spring marks the start of street resurfacing and road repairs. Palatine relies on the state-of-the-art Micro-PAVER software program to evaluate all streets and rank them at or above an accepted standard.

Within a two-year span, the Village's engineering staff rates the quality of streets and enters the collected data into the Micro-PAVER program. Streets rated below "good" are then considered for resurfacing.

## Village To Renew Street Surfaces

Palatine has enacted a street preservation program to keep its roads in good shape. The Micro-Surfacing Street Program is a preventive maintenance activity designed to take relatively new streets (three to five years old) and extend their useful life.

**Street preservation** is designed to maintain and/or restore street surfaces that are in good condition to their original condition. **Street resurfacing** involves repairing damaged streets or those streets that need repair due to age.

As streets age, UV rays oxidize oils at the surface. The result is a loss of surface lines and aggregate materials. Micro-surfacing slows the loss of surface oils, provides skid resistance, prevents rutting and provides a smooth driving surface.

Proposed streets selected for micro-surfacing are:

Elmwood Avenue from Lincoln Street to Palatine Road

Elmwood Avenue from Palatine Road to Northwest Highway

Helen Road from Cedar Street to Salt Creek Bridge

Helen Road from Salt Creek Bridge to Plum Grove Road

Holly Way from Aster Avenue to Capri Drive





## Palatine Road Work Will Resume In March

Palatine Road construction—nearly 70 percent complete—will resume in March. Last summer, labor issues and unexpected utility glitches delayed the \$11.7 million project, funded by the Federal Highway Authority and the American Recovery and Reinvestment Act, for several weeks.

When work resumes, residents can expect two-way traffic on Palatine Road to be shifted onto the new south-side pavement from Smith Street to Plum Grove Road while crews reconstruct the road's north side. Two-way traffic will be maintained from Smith Street to Plum Grove Road.

Eastbound traffic on Palatine Road, from Plum Grove Road to Northwest Highway, will be detoured at Plum Grove Road to Colfax Street. From Plum Grove Road to Kerwood Street, westbound traffic will be moved to the newly constructed westbound lane while crews work on the road's south side.

Drivers are cautioned to be alert at all times since lane widths will be reduced.

Crews are expected to place the final surface lift of hot mix asphalt on the entire project, complete traffic signals, finish roadway lighting, and stripe the final lane configuration by mid-2011.


## BARRY NEW PUBLIC WORKS DIRECTOR

## WAS YOUR PARKWAY OR MAILBOX DAMAGED LAST WINTER?

During heavy snowfalls, it is very difficult to completely clear the snow without damaging some mailboxes or parkways. The Village is not responsible for mailboxes damaged during snow plowing if the mailboxes do not meet Village Code. The Village will not repair mailboxes damaged by non-Village vehicles. The Village's total liability is limited to the cost of replacing a standard metal mailbox and/or standard pre-treated wood post.

When a mailbox is installed, it must be set back 12 inches from the back of the curb, or if there is no curb, 24 inches back from the hard surface of the pavement edge.

The bottom of the mailbox must be 48 inches above grade level. At this height and distance from the curb, the snow and snow plow blade should go under the mailbox and it will be the proper distance to allow the mail to be delivered from the mail truck.

A 4 x 4 inch wooden post or a 2.5 inch metal post can be set into the ground or anchored by a concrete slab set at grade level. The slab may not exceed 24 inches square nor be more than 18 inches deep. If you are planning to install a new mailbox, please install per these regulations.

If you believe your curbside mailbox or parkway was damaged by a Village snowplow, please call the Public Works Department, 705-5200, between 8 a.m. and 4 p.m., Monday through Friday.



# VILLAGE REQUIRES IDENTIFICATION FOR ALL DOOR-TO-DOOR SOLICITORS

This winter, three con artists burglarized a Palatine home by posing as water department employees who were interested in a possible "contamination" in the neighborhood. Two of the perpetrators lead the homeowners out of their home, engaged them in conversation while an accomplice ransacked the house for valuables and fled.



This type of scam activity knows no season and is becoming more prevalent year round. Residential burglars often prey on senior citizens and may even push their way into homes under the pretense that they will perform some handiwork.

Doorstep scams commonly include tree trimming, roofing or seal coating, but imposters have also been known to pose as utility workers or Village employees.

Imposters rely on the fact that victims are poor eyewitnesses and are frequently reluctant to report that they were duped. These swindlers are generally uncooperative with law enforcement and rarely admit criminal involvement.

**THE VILLAGE REQUIRES THAT ALL SOLICITORS HAVE A PERMIT.** Always ask for identification and follow these safeguards when approached by a doorstep solicitor:

- Call 911 if a solicitor refuses to show you a permit.
- Always talk to a solicitor through a closed locked door.
- Never let a solicitor step into your home.
- Never leave a solicitor alone at your door to retrieve a phone, wallet, purse or any item requested; always close and lock the main door before walking away from it.
- Never leave your home unlocked while you are out in the yard.
- Carry a cell phone to call the police anytime, anywhere.

## If Someone Knocks...

Residents should beware of anyone who comes to the door and uses any of these common ploys:

***"We're in the neighborhood taking blood pressure readings."*** ***"We are out of gas and need assistance."***

Remember, the goal is to get inside your home. Thieves will distract you long enough for others to enter through your back door or window.

***"May we come in to check your water pressure or water quality?"*** ***"We're from the gas company... electric company...water department."*** The goal is to accompany you around your home while an accomplice sneaks in, attempting to steal your belongings.

***"We owe you money from an overpayment."*** ***"You owe us money."*** ***"We've found some money...is it yours?"*** They may even threaten to call the police if you don't comply with them!

***"Can you come outside to show me your property line before I cut down these trees."*** This is an attempt to lure you outside while someone else enters your home.

***"I have a winning lottery ticket and want to share the money with you for some cash right now."***

Remember always call 911 to have the police come out and verify anything you may doubt.

- **Day and time request.** Inspections are performed Monday through Friday, early morning, 8–10 a.m., late morning, 10 a.m.–12 p.m. or afternoon, 1–3 p.m. The inspector will arrive any time within the requested timeframe.
- **A 24-hour notice for all inspection requests.** Once the Building Department receives the online request, it does its best to accommodate all



appointments. If a specific request is unavailable, the next open time slot will be provided.

The Building Department confirms all online inspection requests by sending confirmation e-mails.

## VILLAGE TO PENALIZE LANDLORDS OF UNKEMPT RENTAL PROPERTY

Starting April 1, landlords who are non-compliant or neglectful of their rental property within the Village will be subject to additional inspections and higher licensing fees based upon their ongoing and repeated property maintenance violations.

Under the revised rental inspection program approved by the Village Council, rental licensing fees will be based upon condition of the rental property. Property owners who maintain their rental property and have fewer violations will benefit by paying a base licensing fee.

Currently, residential rental dwellings in Palatine are inspected to ensure that properties are maintained to meet health and safety standards, but several problematic properties have had a detrimental effect on the quality of life for residents and a negative impact on surrounding property values.

In an effort to better monitor the condition of these residential rental properties within the Village and to recognize landlords who consistently meet standards, the Village Council revised the rental inspection requirements that will be enforced by the Neighborhood Services Division.

## NEW FIRE STATION TO OPEN IN MAY

Construction of Palatine's newest fire station is scheduled for completion by May 1. Located on the corner of Echo Street and Quentin Road, the station is nearly 65 percent finished as crews continue to work on the building's interior.

The station will house a "jump crew" of one lieutenant and two firefighter paramedics who will respond to medical emergencies as well as fires and other critical situations. The team will work a 24-hour shift with 48 hours off.

Crews and their equipment currently stationed at 455 W. Dundee Rd. will relocate to the new fire house at 1215 N. Quentin Rd. to improve emergency response time for residents living in the northwest region of our community.

The Fire Department has five fire stations and responds to more than 7,000 calls per year.



## STEP INTO RECYCLING WITH NIKE REUSE-A-SHOE

The Palatine Environmental Health Division, in conjunction with the Solid Waste Agency of Northern Cook County, will support Nike's Reuse-A-Shoe program by collecting worn out athletic shoes.

Please do not donate dress shoes, flip-flops, sandals, pool or water shoes, boots, or shoes with metal or cleats. Wet, muddy or shoes with laces tied together will not be accepted.

### Public Works Department Battles Blizzard of 2011



The National Weather Service issued a blizzard warning for Tuesday, February 1 at 3 p.m. They were right on the money.

Most residents heeded the warning, stayed off the streets and watched television news coverage from the comforts of home. Meanwhile, Public Works crews climbed into their trucks at 2:30 p.m., headed toward the Village's ten snow removal routes and plowed until the immediate blizzard response ended the following day at 7:30 p.m.

When the snow stopped falling, crews had plowed 350 miles of street lanes and expended 1,000 man hours. It took the crews just 8.5 hours

to clear and salt Village streets down to the bare pavement.

Public Works Director Matt Barry estimated that his crews expended over 2,000 man hours to complete several other snow removal projects within the Village.

"We didn't anticipate a blizzard of this proportion, but the department's salt acquisition and use coupled with some overtime were well within the snow removal budget," said Barry.

Crews continued their efforts for several days and removed snow piles at intersections, cleared snow from fire hydrants and improved conditions for mail delivery routes.
