50/50 SIDEWALK REPLACEMENT PROGRAM

The Village of Palatine, in a joint effort with homeowners, annually conducts a 50/50 Sidewalk Replacement Program. The goal of the program is to improve the quality of our pedestrian walkway system within the Village.

WHO PAYS TO REPLACE SIDEWALK?

Under the 50/50 Sidewalk Replacement Program, half of the cost is paid by the Village and half of the cost is paid by the homeowner. At this time, the homeowner's cost is approximately \$95.00 per square of sidewalk to be replaced.

HOW IS PARTICIPATION DETERMINED?

Residents who wish to be included in the 50/50 Sidewalk Replacement Program should fill out the attached application. Annual funding for the program is limited and is on a *first-come, first-served basis*. After the application is received, the sidewalk is inspected by Village staff to determine if it meets the criteria for participation. If the requested sidewalk is eligible and funds are available, a bill will be sent to the homeowner.

WHAT IS THE CRITERIA FOR ELIGIBILITY?

Sidewalk that has severe surface deterioration, has significant settlement or heaving, has cracking exceeding 1/2 inches horizontally, or has vertical displacement greater than 3/4 inches, qualifies for the program. In addition, it is sometimes necessary to replace additional sidewalk squares in order to correct the problem. These squares would also be eligible for funding.

WHO PERFORMS THE WORK?

The 50/50 Sidewalk Replacement Program is advertised and competitive bids are obtained for the entire package. For this reason, all work done under this program must be performed by the contractor who has been awarded the project by the Village Council.

WHEN IS THE WORK TO BE DONE?

The contractor will begin replacements in the spring/summer. They will continue until all of the eligible sites have been completed or until the allotted funding has been spent. If there are remaining funds, the contractor may return in the fall for another group of participants.

HOW DOES THE VILLAGE HANDLE UNSAFE SIDEWALK WHERE THE HOMEOWNER IS NOT ABLE OR NOT WILLING TO PARTICIPATE IN THIS PROGRAM?

Because of the liability associated with unsafe sidewalk conditions, the Village will place an asphalt patch over any hazardous sidewalk condition for which they are made aware. The homeowners can then replace the sidewalk when they are financially able.






