



Thank you for registering to use the Citizen Self Service Portal ("Citizen Portal") for the Village of Palatine, Illinois ("Village"). Initial registration to use the Citizen Portal requires that you read the terms and conditions ("Terms and Conditions") listed here and indicate your approval to the Terms and Conditions in the Acknowledgement section at the end of this document.

PURPOSE

The Village of Palatine ("Village") created this Citizen Portal, to provide convenient access to many Village services. Users of the Citizen Portal ("Registered Users") are responsible to review the Village Code of Ordinances and to comply in all respects with Village Code requirements if different from what is stated herein. Your choice to avail yourself of the Citizen Portal is at your own risk and the Village takes no responsibility for the accuracy, security and/or completeness of the extent that there is any conflict between these Terms and Conditions, the Citizen Portal, and any terms and conditions or provisions of the Code of Ordinances of the Village of Palatine shall control.
